**No.SORI(SGA&CD)1-119/2023<sup>(1-119)</sup>**:- In pursuance of the provisions of clause (3) of Article 139 of the Constitution of the Islamic Republic of Pakistan, 1973, the Government of Sindh are pleased to make the following amendments in the Sindh Government Rules of Business, 1986:-

### AMENDMENTS

1. In Schedule-I, in Sr. No.34 "Social Welfare Department" and entries there-against, the following shall be substituted:-

"34.	Social Welfare Department	Directorate of Social Welfare	Director General, Social Welfare."

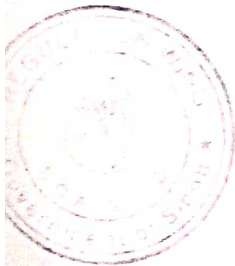
2. In Schedule-II, for Sr. No.34 "Social Welfare Department" and entries there-under, the following shall be substituted :-

### "34. "Social Welfare Department"

- Working for welfare of marginalized segments of the society i.e. children, senior citizens, drug addicts and transgenders.
- Administration of the following laws and the rules framed there-under:-
  - The Voluntary Social Welfare Agencies (Registration and Control) Ordinance, 1961;
  - The Sindh Darul Atfal (Supervision and Control) Act, 1976 (amended from time to time);
  - The Sindh Senior Citizens Welfare Act, 2014;
  - The Sindh Street Children Shelter Home Act, 2018; and
  - The Sindh Charities Registration and Regulation Act, 2019.
- The registration, cancellation, restoration, monitoring and supervision of Non-Governmental Organizations (NGOs) under the Voluntary Social Welfare Agencies (Registration and Control) Ordinance, 1961.
- Matters related to the Sindh Charities Registration and Regulation Act, 2019.
- Preparation and implementation of grant-in-aid policy to Government entities and NGOs engaged in various social services / fields etc.
- Coordination of social welfare programs with other National Building Ministries, Departments, donor agencies and Non-profit organizations at provincial, district and local levels.
- Matters related to Sindh Social Welfare Council.
- Preparation and execution of development schemes of Social Welfare Department through Annual Development Program (ADP), Public Private Partnership (PPP) mode or international financing.
- Capacity building of employees of Social Welfare Department and various Social Welfare Organizations i.e. NGOs and CBOs.
- Matters related to Medical Social Services at tertiary care hospitals.
