- To ensure that children with special need are referred to the institutions providing specialized services to cater their need.
- To implement the Sindh Child Marriage Restraint Act, 2013 at district level.
- To facilitate District Child Protection Unit to organize prevention activities to raise awareness, promote desired sets of behavior and disseminate information regarding child protection.
- To take necessary measures to ensure protection of children during the time of emergencies caused by disasters.
- To identify and induct other stakeholders for developing strong case management and effective referral mechanism.
